- 1. Upon completion of the trial period, you will be sent a payment coupon book for your monthly rental or pay via the credit card listed on this contract. If you decide not to continue, please contact us to pick up the instrument at school. If the instrument is not returned by (JAN 31st) you will be charged the regular monthly rate plus late fees. Monthly Payments which are ten days past due, will be assessed a \$10.00 late fee. Instruments not returned will be repossessed.
- 2. The MusicWorks has the right to charge the undersigned's credit card if a payment is 10 days or more past due. Furthermore, anyone other than the undersigned who lists their credit card, also gives The MusicWorks permission to obtain payment as stated above. ALL CHARGEBACKS AND ASSOCIATED FEES WILL BE PAID BY THE UNDERSIGNED NO EXCEPTIONS.
- 3. If two or more payments become delinquent, The MusicWorks has the right to cancel this contract and pick up the instrument at the school or wherever it may be found. Furthermore, the undersigned will be charged with theft if the instrument is not returned. All legal and/or collections fees, as well as the full retail value of the instrument, will be paid by the undersigned. NO EXCEPTIONS.
- 4. The instrument and its accessories are the sole property of The MusicWorks. Instruments will remain the property of The MusicWorks until the full terms of the agreement have been met.
- 5. Damage insurance WILL NOT cover expendable parts such as reeds, strings, mouthpieces, ligatures, cleaning rods, swabs, drum heads, drum keys, practice pads, sticks, straps, oil, grease, rosin, bows, name tags or negligent/malicious damage to the instrument. There will be a charge for name tags, cleaning rods, bows, carrying straps, mouthpieces, end caps, neck straps not returned with the instrument.
- 6. <u>Damage insurance is null and void if payments become past due</u>. All repairs are to be solely made by The Musicworks. REPAIRS MADE ELSEWHERE WILL NOT BE COVERED. Damage should be reported as soon as possible. In the event of theft, a police report must be filed within 24 hours and The MusicWorks must be notified.
